ORDER

As per proceedings read as first paper above Sri. Saajimon V, Assistant Lecturer in Computer Engineering, Government Polytechnic College, Cherthala was promoted/appointed to the post of Superintendent on Rs. 11910-19350 and posted at Technical High School, Sulthanbathery, Meanwhile a stay was ordered by the Honourable High Court in WP (C) No. 10014/10 filed by Sri. Haridas P S and Sri. Sajeesh P K on the appointment of the Diploma holders who were exempted from acquiring B.Tech.

The Departmental Promotion Committee (Lower) meeting held on 20.07.2010 considered the above case and decided that the person included in the select list who had acquired B.Tech and had not joined in the promoted post had to be included in the revised select list for 2008 and hence the revised select list of Superintendent in Technical High Schools for the year 2008 has been published as per notification read above.
