All Principals of Government Engineering Colleges under this Department are directed to collect and forward the applications for Placement for faculty under Career Advancement Scheme (6th CPC). As per the reference-3rd above, AICTE have issued detailed guidelines for CAS Placement of faculties in Government Engineering Colleges. The candidates who are eligible for CAS placement up to 31/12/2024 under 6th CPC have the opportunity to submit their applications vide reference-4th above.

Faculty are directed to submit the applications through DTE portal. The incumbents claiming more than one placement should apply separately for each stage. Refixation of faculties in Senior / Selection Grade Placements will be considered only w.e.f 01/01/2006.

For considering past service of placement under CAS, experience certificate issued by the appointing authority concerned of that institution should be produced. If any leave have been taken in that period, it should be clearly mention in the Experience certificate. Past service will be counted only as per the conditions stipulated under reference 3rd above.

Those joining the service as Assistant Professor after 5th March 2010 shall have also earned Ph.D (in addition to the requirements to move to the stage-4) to the pay band of Rs.37400-67000 with AGP 9000(stage-4). Year wise PBAS should be produced for each placement.

- The login and password for the principals are provided by the IT division of DTE
- The principals should create departments and add the Head of Department from his/her login
- Faculty should be added to the department by the Head of Department login
- Password for Head of Department and faculty will be generated by the system. Later it should be changed by the faculty themselves.
- It is the responsibility of the Head of Department and the Principal to ensure the accuracy of the uploaded documents
- The progress of the application process can be known from their login
- If suitable data is not available in predefined data, (Drop Down Menu) IT division should be informed
- The data for the software is sourced from MIS software. Any discrepancy should be

All applicants including those who had previously applied for CAS placement and if their eligible date will come after 31/07/2022 should also submit their fresh applications through the online mode.

The applications should be submitted through online mode only. The physical copies of the applications are not needed to be forwarded to this Office.

The last date of receipt of application will be June 5, 2025.
