ORDER

As per the G.O read above, the power of granting sanction of **Condonation** of attendance to the students of Diploma course having shortage of attendance less than 65% is entrusted to the Member Secretary SBTE on recommendation of the committee consisting of Senior Joint Director as Chairman, Deputy Director(general) and Joint Controller of Technical Education as members. The committee shall consider the applications duly recommended by the Principal of those students who have passed more than 50% of subjects of previous semester and completed all academic requirements for the ongoing semester.
