**ORDER**

As per the order read as 10<sup>th</sup> paper above, Government have accorded sanction for deputing the faculty members of Government & Aided Engineering Colleges for pursuing Ph.D (Final Admission) under Quality Improvement Programme for the year 2025-2026.

Under the circumstances, the faculty members shown in the list appended are hereby deputed for admission to Ph.D under QIP for the year 2025-2026, subject to the conditions stipulated in the Government orders cited above.

1. All the faculty members who are deputed for Ph.D under QIP should execute a bond as stipulated in G.O. (Ms) No. 55/77/HEdn dated.12.04.1977, G.O. (Ms) No. 55/08/HEdn dated.24.05.2008 & G.O. (Ms) No. 317/10/HEdn dated.22.09.2010 & G.O. (Ms) No.7/2025/H.Edn dated.06.01.2025 in stamp paper worth Rs.500/- (Rupees Five Hundred Only). The selected teachers who are already in the bonded period consequent on previous deputation should execute a supplementary bond along with the present one.
2. The format of the bond / supplementary bond is included as annexure.
3. Sponsorship certificate will be issued to the deputed faculty members only after verification and acceptance of the bonds submitted.
4. The deputed faculty members should furnish quarterly review progress report to the respective Principal of the College from where they are relieved.
5. On rejoining duty, the deputed faculty members should produce certificates from the respective QIP centers in proof of their successful completion of course.
6. Foreign journeys for paper presentation in connection with the deputation shall be performed only after obtaining prior permission from Government.
7. Requests for journey permission addressed to the Secretary to Government, Higher Education Department may be forwarded to the undersigned sufficiently early through the respective Principals.
8. The Principals should ensure that there occurs no delay in forwarding the journey requests of the deputed teachers to this Office, which are supported by a countersigned check list under appendix – I, the countersigned letter by which the teacher is invited for the foreign conference and the recommendation letter / NOC of the Guide / QIP Centre where the teacher is undergoing deputation.

- c) Applying for any post or sitting any all India or State Government competitive Examination during the course of higher studies, or
- d) Failing to intimate to the government the amount and other particulars in respect of any honorarium or other monies earned by him during the period of his higher studies as above, or
- e) Refusing to hand over and surrender to the Government the whole or part of such honorarium or other monies received by him as aforesaid, as and when required to do so by the Government, or
- f) getting adverse report regarding the progress of his studies or regarding his conduct in and outside the place of higher studies, or
- g) failing to complete the higher studies successfully as aforesaid, or discontinuing the higher studies without the explicit prior permission of Government, or
- h) For faculties going on deputation for ph.D study through QIP deputation, maximum of additional 3 years of time can be granted as extension for completion of Ph.D programme
- i) On completion of higher studies, failing to serve the Government for twice the period of deputation sanctioned by Government as per G.O.No. dated \_\_\_\_\_ and as per order No. \_\_\_\_\_ Dated \_\_\_\_\_ of the Director of Technical Education continuously from the date of rejoining after QIP .i.e, if the deputation is for a period of 2years, the bond period will be 4years and if the deputation is for a period of 3 years, the bond period will be 6years. But the bond period of the members of faculty who retire, will be completed on the date of their retirement, and such other terms and conditions as may be prescribed by the Government, or
- j) Failing to conform to the discipline of the Department or Organization of the Government or any Institute, organization or body selected by the Government where he is posted or
- k) Failing to refund to the Government any over-payment made to him during the course of higher studies as aforesaid, or
