The Hon'ble Supreme Court of India, as per its order dated 18th August, 2025 in Petition for Special Leave to Appeal (C) Nos. 20680-20681 of 2025 filed by the Chancellor, A.P.J. Abdul Kalam Technological University, Kerala and The Kerala University of Digital Sciences, Innovation and Technology appointed a former Judge of the Hon'ble Supreme Court as the Chairperson of the Search-cum- Selection Committee for selection of the Vice-Chancellors of these Universities. The learned Chairperson has been authorized to constitute separate or joint Search-cum-Selection Committees for these Universities and the Department of Higher Education, Government of Kerala has been nominated as the Nodal Department of the State Government to issue advertisements giving wide publicity, while inviting applications for the posts of Vice-Chancellor of these Universities.

3. The eligibility conditions for candidates for consideration for the post of Vice-Chancellor are as follows:

3.1. Qualifications

- i. The candidate should be a person possessing the highest level of competence, integrity, morals and institutional commitment.
- ii. The candidate should be a distinguished academician, with a minimum of ten years of experience as Professor in a University or ten years of experience in a reputed research and/ or academic administrative organisation with proof of having demonstrated academic leadership.

3.2. Age limit

The candidate should not have attained the age of sixtyone years on the date of notification.

3.3. Term of Office

i. The candidate selected and appointed as Vice-Chancellor shall subject to the terms and conditions of appointment, hold office for a period of four years from the date on which he/ she enters upon his/

her office or till he/ she attains the age of sixty five years, whichever

is earlier.

ii. The term of office of the Vice-Chancellor shall form part of the

service period of the incumbent making him/ her eligible for all

service related benefits.
