Subject: Entertaining Foreign Diplomats of India by various State Governments-reg.

Respected Mam / Sir,

We are in receipt of communication from security Agencies conveying the risks involved in facilitating visits of foreign nationals (including diplomats posted in India) to vital critical infrastructure like DRDO, Space Agencies and AI based start-ups etc.

2. The critical infrastructure, as you are aware, are sensitive areas which are off-limit to foreigners (including foreign diplomats posted in India). Entertaining such visits will jeopardise national security and may result in acts of sabotage, espionage etc. It is, therefore, requested that you may personally sensitize the Government Officials under your jurisdiction dealing with such visits about the risks associated with facilitating such visits and MEA may be consulted on all such visit requests from foreign Embassies/High Commissions/Consulates located in your state before granting/facilitating such visits.

3. For information, I am enclosing the list of territorial divisions pertaining to each country so that whenever such requests come from a foreign diplomat of that country, state authorities may obtain prior permission from the concerned territorial division. A copy of this request may also be shared with this division at jscpv@mea.gov.in for information.
